

The plan is a requirement of the Federal Disaster Mitigation Act of 2000 (DMA 2000) and must be updated every five years in order to maintain eligibility for certain federal disaster assistance and hazard mitigation funding programs.

Development of the plan is under direction of the County's Emergency Management Director in cooperation with a planning team of representatives from County departments, local municipalities (city and township), school districts, and other key stakeholders such as utility providers. The planning team is responsible to provide feedback required for the plan update, including the ranking of hazards and identification of strategic, cost-effective mitigation activities that may reduce future losses for the County and individual jurisdictions. Some mitigation activities may be eligible for future FEMA Hazard Mitigation Assistance (HMA) grant funding, such as: localized flood reduction measures, property acquisition and relocation/conversion to open space, infrastructure retrofits, wildfire mitigation, and safe room construction or retrofits to provide immediate life-safety protection for people vulnerable to tornado and severe wind events.

The Steele County MHMP also incorporates the concerns and needs of townships, school districts, and other stakeholders participating in the plan.

Steele County is vulnerable to a variety of potential natural disasters, which threaten the loss of life and property in the county. Hazards such as tornadoes, flooding, wildfires, blizzards, straight-line winds, ice storms, and droughts have the potential for inflicting vast economic loss and personal hardship.

According to Steele County Emergency Management Director, Mike Johnson, "Hazard mitigation planning is a central part of our emergency management program. Understanding the natural hazards that can cause serious impact to our communities and taking action to reduce or eliminate the impact of future disasters makes us more resilient. Hazard mitigation helps us to break the cycle

of damage and repair caused by things like flooding, ice storms, and severe wind events that can damage property, stress economies, and threaten life safety in our county."

Examples of hazard mitigation include actions such as improvement of roads and culverts that experience repetitive flooding, construction of safe rooms at campgrounds, parks, trailer parks or schools to protect lives in the event of tornados or severe wind events; burying powerlines that may fail due to heavy snow, ice or wind storms; ensuring timely emergency communication to the public through warning sirens and mass notification systems, and conducting public awareness and education campaigns to help people to be prepared to take safe action before, during, or following a hazard event.





Steele County has completed an updated draft of the Of the County's Multi-Hazard Mitigation Plan (MHMP) as required by the Federal Disaster Mitigation Act of 2000 (DMA 2000). Local jurisdictions are required to update the plan every five years to remain eligible for pre-disaster and post-disaster mitigation grant programs.

Community involvement and feedback are vital to the success of the plan. Steele County invites public review and feedback of the draft plan prior to submitting it to the State of Minnesota and the Federal Emergency Management Agency (FEMA) for review. A copy of the draft MHMP and a survey for public feedback is available online at https://scse.d.umn.edu/steele-county-mhmp. The plan review and comment period will be open until Wednesday, September 20.

The National Weather Service has initiated Geo-Targeted Warnings with Polygons designating the warning area. They no longer issue warnings by county. In addition the IPAWs system issues geo targeted warnings.

Severe Summer/Winter Storms

(Steele County) Set up reporting procedures with local officials, dispatch and law enforcement. The procedures are in place for both winter and summer storms. Warnings are initiated through the Rice / Steele Dispatch Center or the National Weather Service.

Severe Summer/Winter Storms

(Steele County) Work with surrounding counties, Rice and Waseca, on City Watch project.

Severe Summer/Winter Storms

(Steele County) Partnered with Rice County on the CodeRed notification warning system/project initiated in May 2010.

Severe Summer/Winter Storms

(Steele County) Ensure all sirens are compliant with FCC narrow banding mandate – existing VHF frequencies will be obsolete as of January 1, 2013 and equipment must be compliant.

Severe Summer/Winter Storms

(Steele County) Hire a person (Volunteer Coordinator or Assistant Emergency Manager) committed to sustain current programs and assist County Emergency Manager with future funding opportunities.

A Deputy Emergency Management Director is in place.

Severe Summer/Winter Storms

(Steele County) SE Regional I partnership is ongoing.

Severe Summer/Winter Storms

(Steele County) Steele County takes the role of lead county in regional efforts due to Emergency Manager President and Past President of AMEM.

Severe Summer/Winter Storms

(Steele County) Develop guidelines for homeowners describing what they can do to protect their home from lightning strikes.

Severe Summer/Winter Storms

(Steele County) Install backup power generators at critical facilities/infrastructure. Two current needs are the Owatonna Airport and City of Owatonna Public Works facility. *Continue to work with Ellendale, Medford and Blooming Prairie to identify critical infrastructure that needs backup generators.*

Severe Summer/Winter Storms

(Owatonna Public Utilities) Due to the 2010 flooding, Owatonna Public Utilities identified several mitigation actions. One project is to relocate a transmission substation outside of a floodplain. The other mitigation action is to bury or reinforce power lines to protect them from the natural elements.

Flood

(City of Blooming Prairie) Starting fall of 2010 the City will be constructing a storm retention pond in the NW section of the community to control storm water entering system from the rural township area west of the city.

Flood

(City of Blooming Prairie) Starting in 2011 the City will be replacing and upgrading storm water system, sanitary sewer and water main from 4th Ave NW to State Hwy 218 along th3 3rd Street corridor. The 3rd Street project will upgrade the storm sewer system to reduce local street flooding. The project will also eliminate cross connections between sanitary sewer and storm sewer. The project includes the extension of an 8" water main, which will complete the looping of an 8" water main around the community.

Flood

(City of Medford) Study the flooding that happened to the chalet and the park and identify what options there are to minimize or eliminate the flooding.

Flood

(City of Owatonna) Study how access to City facilities can be gained during a flooding event along the Straight River.

Flood

(City of Owatonna) The U.S. Geological Survey representative (Eric Wakeman) made official recommendations about the type and number of monitoring gauges needed in Steele County. Two online flood gauges were installed in Steele County. The first addressed flooding on Maple Creek. The second was installed on the Straight River in Owatonna.

NOT COMPLETED (DELETE)

The following mitigation actions from the past MHMP have been deemed as not relevant and will be removed from the plan update.

No mitigation actions were deleted from the 2011 plan.

NOT COMPLETED (ONGOING/KEEP FOR PLAN UPDATE)

The following mitigation actions from the past MHMP have not been completed, have been deemed as still relevant and will be carried over into the plan update. Actions will be revised as necessary.

Severe Summer/Winter Storms

(Steele County) Evaluate the county's current warning system: how county is notified; who is notified; how people and organizations within county are notified. Steele County residents receive emergency warnings through the PSAP with IPAWs, the Everbridge Emergency Warning System, NOAA All Hazard Radios, and through the outdoor emergency warning siren system using voice and siren.

Severe Summer/Winter Storms

(Steele County) Expand and organize a network of trained SKYWARN Spotters within all sections for coverage throughout Steele County. (See Above) Steele County has trained National Weather Service SKYWARN Instructors who provide annual training sessions for county spotters, law enforcement and fire departments.

Severe Summer/Winter Storms

(Steele County) Expand, train and organize Ham Radio Operators to enhance communications. Steele County has trained instructors that provide annual amateur radio instruction and testing. The group also holds regular meetings and participates in field days.

Severe Summer/Winter Storms

(Steele County) Cross train CERT/SKYWARN members to identify and notify officials of upcoming storms and report/respond to any passing storm damage. With continuing increasing membership in these organizations, there are many that are cross-trained. Cross training of CERT and SKYWARN members occurs. Many members from CERT, Amateur Radio and SKYWARN are cross-trained. This is voluntary depending on member interest.

Severe Summer/Winter Storms

(Steele County) Create Spotter tools – Steele County maps with GPS coordinates and training documents. Grant funds purchased 5 wind speed gauges used by SKYWARN. The SKYWARN/RADIO base has GR level 3 radar software with a goal of purchasing level. The County has provided Instant Alert for 2 years, internet access in the base, and the GIS person works closely with the group for maps/map tools. Computers, furniture and printing needs have been donated by various local businesses. The SKYWARN program has a response plan that assigns spotters to pre-determined locations within the county that have been identified as safe spotting locations with good vantage points. What remains to be done is coordinate all spotters within the county. This includes Steele County SKYWARN, Law Enforcement Spotters, and Fire Department Spotters. With the addition of the Integrated Public Alert System with the Everbridge Emergency Warning System the Public Should Receive Geo targeted Tornado Warnings in Steele County.

Severe Summer/Winter Storms

(Steele County) Work with surrounding county SKYWARN groups for coordinated large area warning and notification coverage. Multi county networking Need to improve communications between the other county EOC's and spotters.

Severe Summer/Winter Storms

(Steele County) Encourage more volunteers to become active in the severe storm spotters network (SKYWARN, CERT, Ham Radio, etc.). These programs continue to grow in numbers. *Annual training is provided in Steele County for volunteers to be trained through the National Weather Service SKYWARN spotter program.*

Severe Summer/Winter Storms

(Steele County) County entities address the language barriers in communicating disaster preparedness information and disaster warnings to the non-English population groups. This information is provided through ECHO. http://www.echominnesota.org/library/severe-weather-warnings. Echo Increase access to lifesaving emergency information by facilitating efficient mass-media messaging in multiple languages.

Severe Summer/Winter Storms

(Steele County) Continue education campaign on NOAA weather radios to the public. Spring education campaigns done via radio, TV and newspapers. Provide weather radios to special needs populations. Grant funding was used to provide NOAA All Hazard Weather Radios in Schools and Public Gathering Points in Owatonna. Weather Radios have been promoted through SKYWARN and anyone that purchases a NOAA Weather Radio can drop it off at the Owatonna Fire Station and SKYWARN members will program it for free to the Steele County Codes.

Severe Summer/Winter Storms

(Steele County) Activate City Watch Warning Notification system secured with Regional Grant funding.

City Watch was discontinued and replaced by the Everbridge Emergency Warning System. The new system works better with the dispatch center equipment. IPAWS was also implemented into the system for emergency warnings.

Severe Summer/Winter Storms

(Steele County) Two new fire sirens in Blooming Prairie. The City has grown to the Southwest and the residents in the area can't hear the siren located in the center of town or the siren located on the northwest area of town. A siren in the industrial park is also needed. New outdoor emergency warning sirens were installed in Ellendale, Blooming Prairie and Owatonna. In Owatonna the siren system was completely replaced with new sirens and voice sirens were installed at Lake Kohlmeyer, Downtown, the water park and at the Steele County Fairgrounds. A new voice siren will be installed at Brooktree Golf course.

Severe Summer/Winter Storms

(Steele County) Ensure citizens of all cultures understand warning system. This is accomplished through a media campaign for Severe Weather Awareness Week with the National Weather Service. Steele County also participates in the Statewide Tornado Drill in April each year.

Severe Summer/Winter Storms

(Steele County) Foster partnerships with surrounding counties to create regional partnerships. Steele County Emergency Management participates in a Joint Powers Board which consists of Emergency Management Directors from Homeland Security Emergency Management Region 1. There are montly meetings to promote regional initiatives.

Severe Summer/Winter Storms

(Steele County) The Emergency Manager, Utilities and CAER group continue to work with the County Planning Commission and staff to modify county subdivision regulations to require burial of all new power distribution lines before any new subdivision plats will be approved. Steele County CAER continues

to meet monthly. At every meeting portions of the Emergency Operations Plan is reviewed by members for the community.

Severe Summer/Winter Storms

(Steele County) Work with city and county staff, and utilities to minimize planting of tree species near power lines and require burial of power lines in new subdivisions.

Severe Summer/Winter Storms

(Steele County) Evaluate the readiness of all homes and public buildings for preventing damage from lightning. This is accomplished through the public utilities.

Severe Summer/Winter Storms

(Steele County) The Emergency Manager works with the County Highway Department and Minnesota Department of Transportation to limit travel on major county highways during hazardous driving conditions by blocking entrances to the major highways using freeway gates. Steele County has been designated as an Interstate 35 closing point for Winter Weather by the Minnesota Department of Transportation. Emergency Plans have been developed to facilitation the closing of the freeway and opening of a shelter at the National Guard Armory.

Severe Summer/Winter Storms

(Steele County) Continue education and awareness campaigns.

Severe Summer/Winter Storms

(Steele County) Assure preparedness of public shelters to handle needs of citizens and travelers. Steele County has a shelter plan and has trained CERT members how to open the shelter at the National Guard Armory in Owatonna.

Severe Summer/Winter Storms

(Blooming Prairie) Conduct study to review equipment - Complex distribution study will analyze the whole electrical system; equipment (capacitors, transformers, conductor), outage records, critical loads, load management, projected loads and development, upcoming road construction (state and local), and sub-station information to identify critical loads.

Severe Summer/Winter Storms

(Blooming Prairie) Conduct study to review equipment - Study will result in some future mitigation projects: sort out weak point areas to be protected, more grounding, more lightning protection, and more safety.

Severe Summer/Winter Storms

(Blooming Prairie) Conduct study to review equipment - Build computer model of system to run a load study, perform analysis and identification of construction requirements, cost estimations of the construction requirements, alternative analysis, and a written report to identify the projects, costs, and locations.

Severe Summer/Winter Storms

(Blooming Prairie) Upgrade system and install new services based on the study and community needs.

Severe Summer/Winter Storms

(Steele-Waseca Cooperative Electric) SWCE continues to protect the electrical distribution system by continuously doing line and pole inspections, trimming trees and vegetation that imperil power lines and

inspecting underground power lines. SWCE will look of opportunities to protect the power distribution system by reinforcing transmission lines or burying lines underground when feasible. Specific projects need to be identified.

Flood

(Steele County) Use the experience of the historic flood of September 2010 to identify other mitigation projects. Specific projects need to be identified in each community.

Flood

(Steele County) Study how to protect or relocate the County Highway facilities. The relocation of the County Highway Facility is underway.

Flood

(City of Medford) Study and identify what other areas are vulnerable to flooding along the Straight River and identify what projects might protect those areas. Bank erosion needs to be controlled.

Flood

(City of Owatonna) Targeted areas in Owatonna have been identified where the funding can be utilized for acquisition or relocation; houses along Lemond Road, North Elm Avenue, and Walnut Avenue. Other properties may make sense to acquire due to localized flooding. Significant improvement has been made in these areas through property acquisitions. Only a small number of properties remain. A new area for property acquisitions is Maple Drive.

Flood

(City of Owatonna) According to the City Planner the cost to acquire and relocate the homes and businesses in the targeted areas would be over \$2 million. *Update project estimates to include remaining properties and the new area.*

Flood

(City of Owatonna) Implement Storm sewer improvements. The city completed a storm water study that recommends improvements to the Storm Water System. The recommended improvements include pipe upgrades, retention ponds and sedimentation ponds. Due to major rainfall events in 2007, certain areas within the city received flooding from the storm sewer system. The City conducted a study of the flooded areas and identified 8 specific areas that require flood mitigation measures. The flooding mitigation in the downtown area by the library has not been completed. New Specific projects need to be identified in the Maple Creek watershed.

Flood

(City of Owatonna) Use the experience of the historic flood of September 2010 to identify other mitigation projects. *In addition Steele County was declared a Presidential Disaster area in 2016 because of significant rainfall and flooding.*

Flood

(City of Owatonna) Study how the impacts along Maple Creek might be lessened. Need a study to identify the problem areas and recommend mitigation strategies.

2017 Local Mitigation Capabilities Assessment Report

As part of the 2017 Steele County Multi-Hazard Mitigation Plan update, city and township jurisdictions as well as County departments were invited to respond to a "Local Mitigation Capabilities Assessment" (LMCA) questionnaire to provide information about the current capabilities they have in place to support hazard mitigation, as well as any identified gaps or deficiencies. CITY OF BLOOMING PRAIRIE, MN

Q1. What <u>plans</u>, <u>authorities</u>, <u>or policies</u> are in place to help accomplish mitigation in your community?

- The City of Blooming Prairie just updated their 20 year Comprehensive Plan (2016).
- The City Administrator represents the City Council on all the City's Commissions and Boards.
- The City Center and Fire Training room are outfitted with internet services and phone drops to operate as command center. During the 2004 rain event in Steele County both FEMA and Red Cross used the facility.

Q2. What <u>staff</u> (organizational capacity) are in place to help accomplish mitigation in your community?

- The City has a Planning & Zoning Commission, Fire Commission, Police Commission and Ambulance Commission.
- The City of Blooming Prairie Emergency Manager is a full-time Police Officer that represents the Police Dept., Fire Dept. and Ambulance service in any mitigation.

Q3. What programs are in place to help accomplish mitigation in your community?

- The City participates in the Steele County Emergency Alert System and provides emergency notification on the City's Facebook site.
- The Blooming Prairie Fire Dept. does fire drills annually during Fire Prevention.

Q4. What <u>funding or other resources</u> are available to help accomplish mitigation in your community?

 The City received PFA funding after the 2004 rain event to eliminate street flooding in the north section of the community. The City is slowly moving up the PPL list for funding to assist with eliminating street flooding on the south half of the community.

Q5. What <u>program gaps or deficiencies</u> do you feel exist that are a barrier to accomplishing mitigation in your community?

- The City needs funding to eliminate sewer cross connections and street flooding along 2nd Street South.
- The City does not currently have a tornado safe facility that can be used by travelers.

- Our schools practice tornado drills on an annual basis.

- The City has worked with state and federal partners to address mitigation efforts following past flood disaster events.
- The City has utilized State funding to purchase and remove structures within the floodplain.

Q5. What <u>program gaps or deficiencies</u> do you feel exist that are a barrier to accomplishing mitigation in your community?

 The City needs additional funding to buy out properties and improve roads that experience repetitive flooding.
