American Red Cross

RACES/ARES

Held annual Field Day event on Jun 24/25 at Willow Creek School. Field Day is a combination emergency communication exercise and contest. Operated 5 transmitters with a multitude of different antennas erected. High point was getting several individuals actively making contacts for the first time.

Working with SCEM, OPU, OSCAR, and MN Repeater Council on a proposal to relocate the Amateur Radio repeater from OPU Tower 9 on 26th St. We have preliminary agreement from all parties involved. Need to finalize agreements for all involved.

Steele County SKYWARN had 2 severe weather activations. June 12th 2:05 pm, this was a damage assessment called for by the National weather service to check for any post storm damage. The second was July 9th at 9:41 pm. A severe Thunder storm was passing through Steele County.

Jerry I. and Dave P. are devoting time to reassessing Spotter locations and developing a new sweet spot map for 2018 and a web based sweet spot information page. It will include maps, GPS locations and extensive photos of every sweet spot. We hope this will make it easier for spotters to find the correct locations and have better escape routes during severe weather.
